Thank you for being here today. It is humbling to be in the company of so many gifted and passionate people committed to the same cause. included with Jean for us to dedicate our efforts in 2024 in their names.

2023 was an impact year for BDC thanks to each of you in this room. Our VDT program is established and running efficiently. We are now part of Hall County Govt training program at Sheriff's Dept with VDT and have interest in from Judge Breakfield for courts. Our first education program was a big success at Cresswind. I can go on but the message here is that our footprint in Gainesville Hall County is firm. Our branding, if that's what you want to call it, has taken roots. And that's not just in Hall County, but in Northeast GA, the state, and Federal Govt. Each of you has contributed your time and expertise in planning, promoting, and/or participating in our program events. And I am grateful to those of you who have made timely donations this past year that have made it possible for us sustain our budget needs. I love the cross section of expertise, passion, and proactive spirit that surrounds this board and commitment that you have made to achieve our goals.

With the addition of new board member Bruce Leyton, we are even stronger. Bruce has participated in our VDTs, was Cloud's dynamic partner in the Cresswind Forum, is instrumental in Wisdom Project VDT next Tuesday, and is the lead on WP reading project. Thank
